The future you want for our city: Let Council know

When City Council agreed to a 0% tax increase for the 2007 City Budget, they knew it was not sustainable. They agreed to do a "priority-setting" exercise to determine what the city will fund in the future and how it will deliver City programs and services.

Plans are now underway for City Council to hold 12 closed-door sessions starting April 23rd at the Municipal - Pineview Golf Course. At this time it seems the only opportunity for public consultation will be an on-line survey.

This is in contrast to the consultative process that led to the creation of the [Ottawa 20/20](#) where hundreds of women and men across the city helped to identify a set of guiding principles that set the course for building a safe, clean, caring and inclusive City.

We want to make sure these principles are maintained when discussing inconsistent options such as outsourcing services (contracting the private sector to provide city services) or gapping (reducing city staff by not replacing vacancies).

The plans made this spring will determine not only what programs and services will be funded but also how they will be delivered. Write or call your City Councillor and the Mayor. Let them know that the priority setting should include open public consultations.
